PRICING DISCLOSURE

The tour price of \$3,935 per person double occupancy is based on a minimum of 50 participants (airfare not included) with rates and tariffs priced effective October 2008. An extremely limited number of single occupancy rooms are available in Paris for both sessions at a single supplement of \$410. There are a limited number of single occupancy rooms available at the Conference Center in Chartres at a single supplement of \$140. If the size of either session falls below 50 participants, an estimated \$125 surcharge may be added; however, should the tour membership fall below 30 participants, Rautenstrauss Travel, Inc. reserves the right to cancel said tour. Payment by check has the advantage of no processing fees. A \$50 fee will be assessed for checks returned due to insufficient funds. Should the U.S. Dollar decrease in value to the Euro from conversion estimates in October 2008, a currency adjustment may be assessed at time of final payment on/before March 30, 2009. This tour price includes all European government taxes as levied at the time of pricing in October 2008. In the event that additional taxes are introduced by governing bodies or existing taxes increase, Rautenstrauss Travel, Inc. may pass on all such additional charges to its individual passengers.

TRIP INSURANCE INFORMATION SHEET

Please Note: Rautenstrauss Travel, Inc. is required to have every tour passenger fill out and sign a Trip Insurance Notification form (included in registration materials), which acknowledges the participant has been offered trip protection insurance and either accepts or declines this coverage.

Travel can mean encountering the unexpected, ranging from the inconvenient to a truly serious emergency. **Traveler's "Travel Select" protection plan offers comprehensive benefits to meet the challenges of travel and helps you enjoy a worry-free trip.**

Here is a synopsis of the benefits of this coverage, recommended by Rautenstrauss Travel, Inc. for France Inward Journey 2009 members (Please note this is a partial description of benefits. **1. Trip Cancellation – 100% of trip costs (\$25,000 limit) and
Trip Interruption – 150% of trip cost (\$37,500 limit)**

Protects travel investments if a trip is cancelled or interrupted. Recover prepaid trip costs for the following covered reasons: Sickness, Accidental Injury or Death; Trip Delay of 50% or more; Bankruptcy/Default; Residence/Destination Uninhabitable; Traffic Accident en Route; Employment Termination/Transfer; Felonious Assault; Terrorist Incident; Death/Hospitalization of Destination Host; Weather; Strike; Burglary; Quarantine; Hijacking; Jury Duty; Subpoena; Military Duty

2. Trip Delay/Missed Connection -- \$750
